**BOOKING CONDITIONS**

- HOTELS:** All reservations are made on a first come, first served basis. If the rooms you request are not available then you will be contacted and offered alternative arrangements.
- FERRIES:** Not included on this tour.
- YOUR TOUR CONTRACT:** At the time of asking for a booking to be made on your behalf, you must complete and sign a booking form agreeing to accept the booking conditions as set out below. Your contract is entered into on the terms and conditions of these booking conditions and the completed booking form must be received accompanied by the appropriate deposit or full payment, at which time, subject to availability of the particular tour, your contract with us is made.
- DEPOSITS AND PAYMENT:** No booking can be accepted unless accompanied by a minimum deposit. **For the Tour** please pay **£300** per person. This is your only commitment until 16 weeks before departure. Payment of the balance remaining after deducting the deposit from the total cost of the tour as expressed in our confirmation/invoice, will be due without further notice 16 weeks before your date of departure. If final payment is not received by that due date, the Company reserves the right to treat your booking as cancelled and you could be liable to pay cancellation charges in accordance with the section below entitled cancellations. Overseas payments: All bank charges involved are to your own account – even Sterling Drafts incur costs to us.
- PRICES:** Prices are valid at the time of going to press as published in the Tour Brochure. The price of your tour is subject to variation by reference to elements covering taxes, and exchange rates. The company will, however, absorb up to 2% of any increase in the price of your tour attributed to any such items and no surcharges will be made less than thirty days before the stipulated departure date. Increases over 2% may be passed onto participants.
- IF YOU CHANGE YOUR BOOKING:** If you want to change any of the arrangements specified on your Booking Confirmation/Invoice, we will do all we can to accommodate your new requirements. An alteration fee of £35 per booking may be charged for any such change to cover administration costs.

**7. CANCELLATIONS:** If you wish to cancel your tour after your booking has been confirmed, you must inform the Company in writing as soon as possible. We will however endeavour to fill your place. But should we not manage to do so, the Company reserves the right to charge you a cancellation fee based on the following scales:

**9. AMENDMENTS BY US:** Tours and activities are based on an economic minimum number of participants. Should this not be reached it may be necessary to either; a) cancel the service and refund any monies paid, or b) levy a surcharge on those still requiring the service. The Company reserves the right to alter either the quoted hotel accommodation to hotels of the same grade, or the tour itinerary, as necessary.

**10. RESPONSIBILITY OF THE COMPANY:** All tickets issued and arrangements made in connection with this tour are made by the Company as principal. The Company accepts no liability for any death, injury, damage, loss, accident or delay arising from any act or default of any person or any matter arising in connection with the tour, and the Company makes no warranty or representation in connection therewith. Accommodation and transport are provided subject to local laws. All personal property is at owner's risk unless insured.

**11. LAW AND JURISDICTION:** The contract between the Company and the Client incorporating these booking conditions and our booking confirmation/invoice shall be governed by the English law and both parties submit to the exclusive jurisdiction of the English Courts.
